3.2 Academic Initiatives – Placement Exams – Interim Academic Dean Kenneth Williams and Academic Dean Cindy Carbone

Academic Deans Cindy Carbone and Ken Williams discussed the reasons OCC uses placement testing for their students:

- It assists to determine if students are ready for college.
- It places students in coursework that is neither above nor below their ability to succeed.
- It assists students in managing their financial obligations toward completing their educational goals.

They discussed the benefits and reviewed data why using ALEKS PPL and Accuplacer for Math and English placement testing is the best fit for OCC.

- These tests have better success rates than Compass, the previous testing used.
- Students are able to take practice components prior to the actual test.
- English testing may be taken up to three times and may be taken online or on site.
- Math placement tests may be taken up to four times, with remediation required before each re-test.
