



Statement of Finances for F-1 Students

Dear Prospective OCC F-1 Student:

U.S. immigration regulations require that OCC obtain reliable documentation that an F-1 student has sufficient funds to adequately pay all expenses while studying at the school. OCC may issue an I-20 only after reviewing and evaluating proof of financial responsibility for the student. Students must prove that \$17,000 exists to attend at least one year of school and that there is a likelihood finances will exist for the second and third year of study.

The following expenses are estimated for students attending the 2009/2010 school year:

Books and Supplies	\$990	(two semesters)
Living Expenses.....	\$8,906	(one year)
Transportation.....	\$1,980	(one year)
Miscellaneous	\$720	(one year)
