- A minimum of thirty (30) semester hours residency required at SHU at 300/400 level.
- Cumulative grade point average must be at least 2.0 to transfer to SHU.
- Courses with a grade of 2.0 or higher transfer to SHU. Courses with a 1.0 grade will transfer within an associate degree; however, it cannot fulfill SHU major requirements.
- SHU will accept up to 6 semester hours of developmental credit and up to 4 semester hours of physical education courses within a bachelor degree.
- OCC students transferring without an associate degree will be evaluated on a case by -case basis.
- Transfer credit may be awarded for military, CLEP and professional licensure.



# ARTICULATION AGREEMENT BETWEEN OAKLAND COMMUNITY COLLEGE AND SIENA HEIGHTS UNIVERITY

# **GUIDING PRINCIPLES**

Oakland Community College (OCC) and Siena Heights University (SHU) agree that students who choose to begin their academic pursuit at OCC and transfer to SHU to earn a bachelor's degree should be provided with a smooth curriculum transition that minimizes the loss of credit and the duplication of coursework while maximizing the utilization and applicability of college level credit earned. Therefore, OCC and SHU agree to enter into this Articulation Agreement (Agreement) as collaborating educational institutions and will maintain the integrity of their separate programs without jeopardizing the intended mission and stated goals of each institution and enter into this agreement as equal and cooperating partners. Furthermore, this Agreement acknowledges that each institution has established and will maintain rigorous standards and expectations for all students enrolled in and working toward the completion of its courses, programs and degrees.

#### ADMISSION & GRADUATION CRITERIA

- 1. Students who have earned an Associate in Arts, Associate in Applied Science, Associates of Business Administration or an Associate of Science degree from OCC and have achieved the minimum overall grade point average of a 2.0 on a 4.0 scale specified by SHU with OCC coursework receiving a 2.0 on a 4.0 scale for all courses (OCC courses where a 1.0 on a 4.0 scale was earned will transfer with an associate degree; however, it will not be applicable towards SHU major requirements.) may transfer all credits earned at OCC to a maximum of 90 semester hours of credit as listed on the associated Articulation Agreement Course and Program Guide without duplicative study to SHU and receive junior standing. Coursework that is taken and not reflected on the Articulation Agreement Course and Program Guide may not transfer or may only be utilized as general elective credit as with remedial, vocational or non-germane courses.
- 2. Students who follow the attached Articulation Agreement Course and Program Guide must also:

- a. Complete a minimum of 30 semester hours of credit for the Bachelor Applied Science degree at SHU.
- b. Complete a minimum of 33 semester hours of credit for the Bachelor of Business Administration degree at SHU with a minimum 2.50 SHU cumulative grade point average is required to complete any business-related academic major.
- c. Complete 30 semester hours of credit at the junior/senior level (300/400) with a minimum of 15 semester hours of credit must be earned at SHU.
- d. Complete a minimum of 120 semester hours of credit between OCC and SHU.
- e. Complete the remaining major/program, degree, graduation and institution requirements listed in the SHU catalog/bulletin.
- 3. Advising of OCC students regarding admission and program requirements at SHU will be the primary responsibility of SHU.
- 4. This agreement does not guarantee OCC students acceptance into SHU and/or the corresponding major/program and/or degree. Under this Agreement, graduates of OCC will receive equal consideration with other students seeking admission to the SHU major/program and/or degree provided applicants meet the prerequisites and requirements for admission to SHU and the corresponding program/major and/or degree.

# **COMMUNICATION RESPONSIBILITIES**

OCC and SHU further agree to communicate any concerning curriculum or policy change(s) (as soon as reasonably possible) which affect the agreed upon relationship between articulated programs at the respective institution. Both institutions reserve the right to amend or revise this Agreement. Any changes must be submitted in writing, agreed to and signed by authorized institutional parties. Responsibility for communication related to this Agreement will be given to Timothy Sherwood, Associate Vice Chancellor for Academic Affairs or his OCC designee and to Cindy L Sutherland, Associate Director of Partnership Relations or her designee at SHU.

- 1. Throughout the life of this Agreement SHU will track the progress and success of participants of this articulation agreement and annually provide the number of OCC students who have applied, enrolled and completed the aforementioned degree by program.
- 2. SHU will identify and annually (prior to August 1<sup>st</sup>) provide OCC with any systemic academic performance issue(s) experienced by OCC students, such as academic courses within the bachelor major/program that have prerequisites that are taken at OCC, resulting in an examination of the corresponding matter(s) by OCC parties.
- 3. Any marketing of the Agreement in print will be subject to the prior approval of both institutions.
- 4. Joint efforts in marketing this Agreement and student recruitment will be pursued with faculty and staff at both institutions communicating information regarding this

Agreement to current and prospective students (i.e. transfer fairs, information sessions, OCC campus visits, etc.).

5. Each institution may provide on its website, a link to the partner institution's website.

# COMPLIANCE WITH LAWS, POLICIES & STATUTES

- 1. To the extent permitted by the Family Education Rights and Privacy Act (FERPA), OCC and SHU agree to share data on student achievement for purposes of assessing program effectiveness. Any exchange by the institutions of student record information protected by the Family Education Rights and Privacy Act (20 USC § 1232g) and implementing regulations (34 CFR Part 99) ("FERPA:) shall occur only in full compliance with FERPA, including, without limitation, committing the receiving institution to limit the use of such information to the purposes for which the disclosure was made, and to impose such limits on any re-disclosure, and the institutions agree to comply with all applicable statutory and regulatory provisions, including, without limitation 34 CFR 99.31, 99.32, 99.33, 99.34 and 99.35. Data provided by SHU as noted in this Agreement will include student performance, utilization of the agreement by the annual number of students enrolled in the corresponding major/ program upon transfer and the number of graduates annually. This information will assist with identifying potential short comings of OCC coursework and the merit of the agreement that may be shared stakeholders.
- 2. Each institution attests that it does not discriminate on the basis of race, color, religion, creed, age, sex, sexual orientation, national origin, material status, handicap or disability, disabled veteran, Veteran era, or other protected veteran status. Furthermore, each institution complies with the American Disabilities Act of 1990, and that it does not discriminate on the basis of "physical or mental handicap" except where there exists a bona fide academic qualification.
- 3. This Agreement shall be governed by and construed in accordance with the laws of Michigan applicable to contracts made and to be enforced wholly within the state Michigan. Each institution shall be separately responsible for compliance with all federal and state laws, including nondiscrimination laws and all applicable sections of the Michigan Handicapper's Civil Rights Act. Illegal discrimination by either institution may be considered a material breach of this Agreement.

#### **TERMINIATION & POST-TERMINIATION**

1. This Agreement terminates July 8, 2023 or four (4) years from the date fully executed (The date which this document has received the signatures from all required parties

from both institutions.), whichever is later; however, either party may terminate this Agreement upon 90 days' written notice to the other institution.

- 2. In the event this agreement is terminated or modified prior to the cessation date OCC students who have selected and designated this program will be given the opportunity to matriculate to SHU within two (2) years beyond the date of termination or modification with an additional two (2) years upon matriculation to SHU to complete the remaining major/program, degree, graduation and institution requirements listed in the SHU catalog/bulletin.
- 3. Should this Agreement not be renewed, students who began this program at OCC shall receive the benefits contemplated by this Agreement and will have three (3) additional years beyond the termination date to complete the remaining major/program, degree, graduation and institution requirements listed in the SHU catalog/bulletin.
- 4. All notices and other communications under this Agreement must be in writing and will be deemed given (a) when delivered personally, (b) on the fourth business day after being mailed by certified mail, return receipt requested, or (c) the next business day after delivery to a recognized overnight courier at the following addresses (or to such other address as either party may have specified by notice given to the other party pursuant to this provision). Other forms of written communication may be used if deemed appropriate and agreed upon by both parties, including but not limited to email where acknowledgement of receipt is required.
- 5. This Agreement constitutes the entire agreement between the institution and all prior discussions, negotiations and understandings, either oral or in writing, are hereby merged. This Agreement supersedes any previous Associate in Arts, Associate in Applied Science, Associates of Business Administration, Associates in General Studies or an Associate if Science degree from Oakland Community College. The invalidity of unenforceability of any provision of this Agreement shall not affect the validity of enforceability of any other provision of this Agreement, which shall be in full force and effect.
