High school guest students (those whose OCC tuition is not being paid by the school district) have their tuition rate determined normally. Early College Programs charged in-district tuition rates. OCC's actual in-district tuition rate for 2015-2016 was \$88.00 and the out-of-district tuition rate was \$171.00.
