

# DEPENDENT Verification Form 2019 - 2020

Your financial aid application was selected for review in a process called verification. In this process we will be comparing information from your FAFSA to copies of your 2017 Federal tax information. Under the financial aid program rules (CFR Title 34, Part 668), the College has the right and obligation to ask you for this information before we can award you financial aid. We cannot process your financial aid application without these documents.

#### What you need to do:

- 1. Complete this worksheet.
- 2. The best way to verify income is by using the IRS Data Retrieval Tool that is part of FAFSA on the Web. If the student and/ or parent(s) has not already used the tool, go to www.FAFSA.gov, log in to the student's FAFSA record, select "Make FAFSA Corrections," and navigate to the Financial Information section of the form. From there, follow the instructions to determine if the student and parent(s) is eligible to use the IRS Data Retrieval Tool to transfer 2017 IRS income tax information into the student's FAFSA.
- 3. Submit the completed worksheet to the Office of Financial Aid. If the student or parent(s) is unable to use the IRS Data Retrieval Tool in FAFSA on the Web, an official 2017 IRS tax return transcript (not a photocopy of the income tax return) may be submitted. To obtain an IRS tax return transcript, call 1.800.908.9946, or obtain one online at <u>www.IRS.gov</u>. Under "Tools," select "Get Transcript of Your Tax Records." You may either retrieve the transcript online or elect to have it mailed to your home address. Make sure you request the "Tax *Return* Transcript," not the Account Transcript.
- 4. You may submit a copy of your 2017 tax return. If you did not keep a copy of your tax return, request a copy from your tax preparer or you may request a copy from the Internal Revenue Service (IRS).
