

**Dear Prospective OCC F-1 Student:**

U.S. immigration regulations require that OCC obtain reliable documentation that an F-1 student has sufficient funds to adequately pay all expenses while studying at the school. OCC may issue an I-20 only after reviewing and evaluating proof of financial responsibility for the student. Students must prove that \$19,500 exists to attend at least one year of school and that there is a likelihood finances will exist for the second year of study.

**The following expenses are estimated for students attending the current school year:**
